Wheatland City Council Proceedings March 12, 2018

Mayor Schnede called the regular meeting of the Wheatland City Council to order at 6:30 p.m. with council members P. Stankee, Denahy, Wiese and Bousselot present. C. Stankee was absent. Also present were city employees Laurie Ganzer and Matt Cavey.

A motion to approve the **building permit for 111 N. Williams St** was made by Wiese with a second by P. Stankee. All ayes.

A motion to approve a 2 phase construction observation contract with MSA Professional Services for the Jefferson St. bridge project in the amount of \$45,000.00 was made by P. Stankee with a second by Wiese. All ayes.

A motion to issue a citation to the **owners of the dogs at 206 lowa Street** that are continually at large despite various warning was made by Bousselot with a second by Wiese. All ayes.

A motion to approve **speed limit signs for Main Street** during the construction of Jefferson St. bridge was made by Denahy with a second by Bousselot. All ayes.

A motion to approve the 3rd reading of **ordinance 182-18** which regulates the use of ATV/UTV's on the streets in Wheatland was made by P. Stankee with a second by Denahy. All ayes.

A motion to approve the 2nd reading of **ordinance 183-18** which is for the water rate increase effective with the July 1, 2018 billing cycle was made by Denahy with a second by P. Stankee. All ayes.

A motion to approve the 2nd reading of **ordinance 184-18** which is for the garbage and recycling rate increase effective with the July 1, 2018 billing cycle was made by Wiese with a second by Bousselot. All ayes.

Sweeping Main Street - The Fire Department will clean Main Street.

A motion to approve the **contract with the Clinton County Sheriff's Office** for \$1,440.60 per month for the 2019 fiscal year was made by P. Stankee with a second by Wiese. All ayes.

A motion to approve the **streets repair bid** with LL Pelling in the amount of \$36,698.10 was made by Bousselot with a second by P. Stankee. All ayes.

A motion to approve hiring a lawyer to **set up a Fire Association** was made by Wiese with a second by Denahy. Yes – Denahy and Wiese. Abstain – P. Stankee and Bousselot.

A motion to approve the appointment of Paul Stankee as the **Fire Chief for the Wheatland Volunteer Fire Department** was made by Wiese with a second by Denahy. Yes – Denahy and Wiese. Abstain – P. Stankee and Bousselot.

A motion to approve **resolution 2018** which is for the pledge of financial support to the Wheatland Community Hall Board for the purpose of a grant application was made by Denahy with a second by Bousselot. All ayes.

A motion to approve **resolution 2018-13** which is for assessing the past due utility bill on account # 3530 to the property taxes was made by P. Stankee with a second by Wiese. All ayes.

Reports – Vine Street culvert will be finished this week. During discussion regarding single source recycling Ganzer noted that citizens have mentioned that they do not feel spending City funds on the system is appropriate if recycling is not enforced as noted in our ordinance. Mayor Schnede declared April 5th as Junior Achievement Day.
