A motion to approve the Wheatland Volunteer Fire Department to pursue a **grant for a generator** which would be shared with the Fire Station and City Hall with a 25% match of funds was made by Rohling with a second by Patterson. All ayes.

A motion to approve the **maintenance agreement** for state owned roads within the corporate limits of Wheatland with the **lowa DOT** was made by Rohling with a second by Patterson. All ayes.

A motion to approve the **ISU – Clinton County Extension Program** to use the park shelter and restrooms August 1 – 6, 2011 was made by Patterson with a second by Steele. All ayes.

A motion to approve up to \$200.00 for the purchase of flowers for Main Street and City Hall planters by the Betterment Committee was made by Patterson with a second by Schulz. Ayes – Steele, Patterson, Schulz, Nays – Rohling.

A motion to adjourn at 7:06 p.m. was made by Rohling with a second by Patterson. All ayes.
