Wheatland City Council Proceedings August 13, 2012

Mayor Noel called the regular meeting of the Wheatland City Council to order at 6:30 p.m. with council members Rohling, Stankee, Steele and Woolard present. Schnede was absent. Also present were city employees Laurie Ganzer and Jayson Cavey.

A motion to approve the consent agenda was made by Rohling with a second by Woolard. All ayes.

Wastewater projects update:

The City is currently waiting on a determination from the IDNR regarding the bio-film project. The FONSI for the projects will be done in the next couple months. Ganzer noted that IEDA has determined that the City will still receive funding on the CDB grant but the amount will be reduced if the bio-film project is approved by the IDNR. Ganzer requested that MSA get a determination from the IDNR regarding the bio-film prior to addressing the issue with IEDA regarding the grant.

Public forum:

Upcoming harvest season was discussed. A concerned citizen requested that the vehicles parked along Lincolnway be moved so that children darting across the street in that neighborhood can better be seen by drivers that need to use the street.

Complaints:

John Marr requested that the property on the corner of Wright Street & Park Road be trimmed back. At the time of the meeting the Park Road side had already been trimmed. Marr also inquired why vehicles that fall under the guidelines of the Junk Vehicle Ordinance have not been removed.

Ganzer was instructed to make contact with the individuals referenced in the complaints.

A motion to paint curbs with no parking areas to open up the **intersection of Jefferson St** and **Main Street** for drivers to see oncoming traffic and not create another 4-way stop at this time was made by Stankee with a second by Rohling. All ayes.

A motion to approve **resolution 2013-01** which is for placing \$7,000.00 into certificates of deposits savings at First Trust & Savings bank for a term of 1 year at a rate of .40% was made by Rohling with a second by Stankee. All ayes.

A motion to **designate school bus stops** at Toronto & Lincolnway, Toronto & Buchanan, Lincolnway & Bennett was made by Woolard with a second by Stankee. All ayes.

A motion to continue saving towards a **new tractor** and not purchase one this year was made by Rohling with a second by Stankee. All ayes.

Rusty water solutions – waiting on feedback from engineers.

A motion to prepare **legislative update ordinances** for \$550.00 was made by Rohling with a second by Woolard. All ayes.

The **Clinton County Sheriff's Office** spent 53.15 hours in the city of Wheatland from June 26, 2012 through July 25, 2012 while on patrol they handled 5 incidents and answered 19 calls. **Reports**:

The fire hydrant at the nursing home is repaired. Security lights at the fire station need bulbs replaced. Street lights that are out were reported.
