Wheatland City Council Proceedings August 14, 2017

Mayor Schnede called the regular meeting of the Wheatland City Council to order at 6:30 p.m. with council members P. Stankee, C. Stankee, Bousselot, Denahy and Wiese present. Also present were city employees Laurie Ganzer and Matt Cavey.

A motion to not allow a tree to be planted in the sewer easement at 108 W. Lincoln way was made by P. Stankee with a second by Bousselot. All ayes.

Railroad Street Bridge – Wiese is working with the railroad to get an answer regarding the sale of the property. Ganzer has contacted Todd Kinney, Clinton County Engineer for assistance further embargoing the roadway. A motion to restrict the road to 15 ton vehicles was made by C. Stankee with a second by Wiese. All ayes.

Jefferson Street Bridge – soil boring are complete, property data is being collected, hydraulic data is being computed.

A motion to not do the legislative updates in the ordinance book was made by C. Stankee with a second by P. Stankee. All ayes. . Steve Rohling – **building demolition**, Mr. Rohling initially asked to be on the agenda as he was unsure if he would meet his

deadline due to Alliant needing to cap the gas line. At this time the building is removed as requested and cleanup is almost complete. George Kastantin issued a complaint on the City's answering machine regarding the burning of the wood from the hotel demolition.

Mr. Kastantin felt this should not have been allowed as it sets a precedence for others in town.

A motion to approve **resolution 2018-03** which is for the approval of the 2017 Streets Financial Report was made by Denahy with a second by Wiese. All ayes.

Mike Block requested the City Council change the City's **ordinance for ATV's** to the times and restrictions stated in the Clinton County Ordinance. Ganzer was instructed to prepare the ordinance for readings.

Reports – Fire Chief, Paul Stankee discussed the current burning ordinance and asked everyone to come prepared to the September meeting to discuss possible changes in the ordinance.

At 7:04 p.m. a motion to adjourn was made by Denahy with a second by Bousselot. All ayes.
