A motion to approve the consent agenda was made by Rohling with a second by Patterson. All ayes.

The **Clinton County Sheriff's Office** spent 60.45 hours in the City of Wheatland from July 26, 2010 through August 25, 2010 while on patrol they issued 9 warnings, 2 citations, answered 15 calls and handled 3 incidents.

During **public forum** no comments were made.

During discussion regarding the **USDA Grant for the computers at the Curtis Memorial Library** Head Librarian, Jill Bachus and City Clerk, Laurie Ganzer informed the Council of the procedures required to obtain the grant. The funds will be disbursed by September 30, 2010.

During discussion regarding **the noon siren** Andrea Werner was present to discuss various reasons that the council should consider discontinuing the noon siren on a daily basis. Werner stated that the siren is unnecessary at noon each day and could be considered a violation of the City's noise ordinance. It is detrimental to the quality of life to many citizens. Werner stated that she understands that the siren needs to be tested monthly and welcomes the sound in the event of a severe storm or tornado.

Cheryl Kastantin added that Lowden and Dewitt have both discontinued noon sirens due to the noise level.

A motion to discontinue the use of the noon siren was made by Rohling. The motion failed due to no second.

A motion to approve **Main Street trick or treating** on October 29, 2010 from 4 p.m. to 5 p.m. with Main Street being closed from the north side of First Trust and Savings Bank drive thru to the south edge of the Washington St and Main Street intersection was made by Patterson with a second by Rohling. All ayes.

A motion to set **regular trick or treat hours** on October 31, 2010 from 5 p.m. until 7 p.m. was made by Rohling with a second by Patterson. All ayes.

During discussion regarding **utility account 24700** a credit was requested due to ah high usage of water for the month of August. No motion was made regarding the situation.

Patty Kalarovich of the Wheatland's Lion's was present to discuss the possibility of a walking **path being placed at the City and the Lion's park.** The item was tabled for further investigation.

A motion to approve the **2010 Annual Financial Report** was made by Rohling with a second by Patterson. All ayes.

A motion to approve the release of HUD loans for document numbers 0316-06,0317-06,0318-06, 0320-06 and 2006-10566 was made by Rohling with a second by Patterson. All ayes.

During **reports** Cavey informed the council that he is working with the IDNR to do a series of test for the City water source to confirm we are back in compliance after the changes made to the treatment system.

Mayor Noel discussed the need to move forward with seals for manhole covers to the storm sewers. Noel stated that any infiltration problems that can be addressed before needing to move forward with expanding the wastewater treatment facility would be proof to the IDNR that we are taking the problem seriously.

Mayor Noel discussed the need to raise manhole covers that are getting recessed and leaving rather large potholes.

At 8:07 p.m. a motion to adjourn was made by Patterson with a second by Rohling . All ayes.
