A motion to approve **resolution 2017 – 07** which is for the approval of the City's computer security policy was made by P. Stankee with a second by C. Stankee. All ayes.

A motion to approve **resolution 2017 – 08** which is for the approval to certify to the County Treasurer the past due utility bill for utility account 6001 was made by P. Stankee with a second by Bousselot. All ayes.

A motion to approve **resolution 2017 – 09** which is for the approval to transfer \$21,000.00 from the general fund to the garbage fund to pay for the purchase of the new garbage cans was made by P. Stankee with a second by Denahy. All ayes.

A motion to approve **resolution 2017 – 10** which is for the approval to certify to the County Treasurer the past due utility bill for utility account 42100 was made by C. Stankee with a second by Weise. All ayes.
